Important dates & fees - March 29, 2019 - Last day to submit taxes to guarantee completion by April 15, 2019. March 23, 2019 - Last day to have a scheduled tax preparation appointment. April 15, 2019 - 2018 1040 Income Tax Returns due. Our tax preparation fees are based on organization of information, number of forms required to file, and complexity. Our pricing will be a little higher this year because of the extensive changes made by the Tax Cuts and Jobs Act. We have spent many hours of training on the new law in order to help our clients. Prices are subject to change if changes are made after already completed return. Extension filing fee is \$60 and you must notify me in writing to request an extension, electronic copy (pdf) of return is \$25 for each year and for each form. Please drop your taxes off if possible but if you need an appointment with George there is an additional meeting charge of \$75.00.

<u>Tax Cuts and Jobs Act (TCJA or the Act)</u> - 2018 has marked the most changes to income taxation since the Tax Reform Act of 1986. Most provisions of the Tax Cuts and Jobs Act (TCJA or the Act) passed at the end of 2017 and became effective in 2018.
